# MINUTES OF THE PARISH COUNCIL MEETING HELD AT 7.30pm ON 21st May 2020 BY REMOTE VIDEO CALL

The meeting could not be conducted face-to-face due to the restrictions imposed during the Coronavirus pandemic. The Council took advantage of The Local Authorities (Coronavirus) (Flexibility of Local Authority Meetings) (England) Regulations 2020 allowing local authorities to conduct meetings remotely.

#### 01.20 Election of Chairman

The Clerk asked for nominations for Chairman. It was proposed by Councillor Hall and seconded by Councillor Roberts and approved without opposition that Councillor S. Scott be elected as Chairman for the ensuing municipal year.

#### 02.20 Chairman to sign Declaration of Acceptance of Office

Councillor Scott signed the Declaration of Acceptance of Office, and this was acknowledged by the Clerk.

## 09.20 Matters arising from the minutes of the Parish Council Meetings of 16 January and 30 January 2020

Councillor Roberts reported that the signage around the Parish had now been installed.

There are a few more kits still available for those households who have not yet claimed theirs.

Councillor Roberts will submit another article for the Village Life magazine to ask anybody who still has not claimed and kit and wants one to get in touch with him

There are a few businesses around the area who are willing to buy additional signage to have erected close to their premises. Councillor Roberts will make enquiries regarding availability and pricing from the 'We Don't Buy Crime" team.

#### 11.20 To receive report from Shropshire Councillor

Cllr Wild reported that there has been an increase in thieving in the local parishes, particularly targeting 'quad bikes' on farms.

Cound residents have been very good at supporting one another and looking out for neighbours during the CV19 lockdown. If anybody knows of any assistance required from any of the Shropshire Council departments Cllr Wild is always willing to help.

Most Shropshire Council staff have continued to work (a lot from home) through lockdown. Councillors agreed that it is highly commendable that services such as the bin rounds have continued uninterrupted.

Cllr Scott asked about the issue on Cressage bridge which has been under traffic control lights for some weeks now. Shropshire Highways came in to mend a pot-hole, but discovered a huge 'void' under the bridge. An engineers' report is needed. The choice was either close the bridge altogether or make it single track under controlled lights. It may be some time before it can be remedied.

#### 12.20 To receive the defibrillator audit check for the period

Councillor Roberts had performed the audit checks for the period up to 20<sup>th</sup> May 2020. There were no issues to report.

New defibrillator pads had been purchased and installed as previously approved.
